Authors and Editors

Marc Boone (born 1955), full professor of Medieval History at the University of Ghent (Belgium), dean of the Faculty of Arts and Philosophy (2012–2018); member of the Royal Flemish Academy of Belgium, honorary president of the European Association for Urban History. Editor of the series ›Studies in European Urban History, 1100–1800‹ (Brepols editors, Turnhout). Research fields: social and political history of the Late Middle Ages, urban history, history of the dukes of Burgundy, historiography. Recent publications concern, for example, studies on the urban society in the ancient Low Countries (2010), an article on medieval Europe in ›The Oxford Handbook of Cities in World History‹ (2016) as well as a paper on Henri Pirenne (1862–1935) and European history (2017).

Gerhard Fouquet (born 1952) studied History and German Philology at the Universities of Gießen and Mannheim (Germany). Since 1996 professor for Economic and Social History at the University of Kiel (Germany). From 2005 to 2008 prorector, subsequently (up to 2014) president of the University of Kiel. In 2013 he received an honorary doctorate from the Dalhousie University (Halifax, Canada). Since 2012 deputy chairman, since 2014 chairman of the steering committee of the project ›Residenzstädte im Alten Reich/Residential Cities in the Holy Roman Empire (1300–1800)‹ of the Göttingen Academy of Sciences and Humanities. Research areas: social and economic history of the Late Middle Ages (thirteenth to sixteenth centuries), especially social history of the medieval church, constitutional and economic history of the German principalities, culture of town and nobility, social history of labour, and environmental history.

Holger Th. Gräf (born 1960) studied Medieval and Modern History and Geography at the Universities of Gießen (Germany) and Leicester (UK) 1982–1988. In his MA-thesis (1988) he dealt with ›Leicestershire Small Towns and Pre-Industrial Urbanization‹ and in 1992 he earned his Ph.D. with a thesis on ›Religion and International Politics in the Age of Confessionalization. The Example Hesse-Cassel‹. Afterwards he became assistant at the Historical Institute of the Humboldt-University, Berlin (Germany), and in 1995 Brittingham Visiting Scholar at the Institute for Research in the Humanities, University of Wisconsin in Madison (USA). Since April 1996 he has been ›Akademischer Oberrat‹ at the Hessian Institute for Regional History. He is frequently teaching courses in German Early Modern History at Marburg University (Germany) where he was appointed as an honorary professor in 2009. His fields of research cover urban, military and political history as well

as visual history and historiography. With a regional emphasis on early modern Hesse, his work refers also to the Netherlands, Switzerland and Ottoman Turkey.

Miha Kosi (born 1965) is senior research fellow at the Milko Kos Historical Institute, Research Centre of the Slovenian Academy of Sciences and Arts (ZRC SAZU) in Ljubljana, and lecturer in Medieval History at the Faculty of Humanities of the University of Primorska in Koper (Slovenia). He graduated in History and Geography at the Faculty of Arts in Ljubljana in 1996 and reached a Ph.D. in Historical Sciences at the University of Ljubljana in 2001. His main research interests lie in medieval history: urban history, history of trade and transport, history of the crusades and the military orders, historical geography. He is a member of the Atlas Working Group of the International Commission for the History of Towns (ICHT) and of the Society for the Study of the Crusades and the Latin East (SSCLE). His works include monographs on the history of transport and trade (1998), on the origins and early development of medieval towns in the area of present day Slovenia (2008) and on the military and political history of the territory of the Karst (2018).

Friedrich Lenger (born 1957) studied History, Sociology, Political Science and Cultural Anthropology at the University of Michigan in Ann Arbor (USA – MA 1979), Bielefeld University and Düsseldorf University (Dr. phil. 1985). Lecturer/assistant professor at Tübingen University 1985–1994, associate professor at Erlangen University 1995–1999, Chair for Medieval and Modern History at Gießen University since 1999 (all Germany); visiting professor at St Antony's College, Oxford (UK, 1997/98), and Georgetown University (USA, 2001/02). Major publications concern, for example, the social history of craftsmen since the nineteenth century, life and work of Werner Sombart (1863–1941), the history of European cities in the nineteenth and twentieth centuries as well as the global capitalism in historical perspectives of historiography, theory and science. In 2015 he received the Gottfried Wilhelm Leibniz Prize awarded by the German Research Foundation. Currently, he is working on the history and theory of global capitalism.

Pierre Monnet (born 1963), attended the École Normale Supérieure (Paris, France) from 1984 to 1988 and obtained his agrégation for History in 1987. Following the completion of his doctoral thesis on the elites in Frankfurt/Main in the fourteenth and fifteenth centuries, he became a full-time lecturer at the University of Burgundy (Dijon, France, 1994–1996) before joining the Mission Historique Française en Allemagne in Göttingen in 1996, which he headed from 1999 to 2003. With the completion of his habilitation on politics and communication of German cities during the Late Middle Ages in 2003, he was awarded a professorship in Medieval History at the University of Versailles/Saint-Quentin-en-Yvelines (France) and went on to become a research director at the École des Hautes Études en Sciences Sociales in Paris in 2005. From 2007 through 2011, he was vice-president, then president of the Franco-German University in Saarbrücken (Germany); since 2011 he has headed the Institut franco-allemand de sciences historiques et sociales at Frankfurt University (Germany). His research fields are the history of cities and of urban societies in the Middle Ages, especially within the Holy Roman Empire; the processes of memory

and social distinction in the Middle Ages; global history in the Late Middle Ages; the comparison of political structures of France, the Holy Roman Empire and the Kingdom of Bohemia in the Late Middle Ages; and the historiographical transfers between Germany and France.

Matthias Müller, professor of Art History (with a focus on medieval and early modern times) at the Institute for Art History and Musicology at the Johannes Gutenberg University Mainz (Germany, since 2006); 2002–2006 interim professor (Chair of Art History) at the Caspar David Friedrich Institute of the University of Greifswald (Germany). Vice-president of the Mediävistenverband e. V. and chairman of the Rudolstädter Arbeitskreis zur Residenzkultur e. V., member of the steering committee ›Residenzstädte im Alten Reich/ Residential Cities in the Holy Roman Empire (1300–1800)‹ of the Göttingen Academy of Sciences and Humanities. Editor of Art History at ›Europäische Geschichte Online (EGO)‹ (edited by Irene Dingel and Johannes Paulmann, Leibniz Institute for European History Mainz). Research and publications on forms of representation, historicity and culture of remembrance in architecture from the Middle Ages to the present, stylistic concepts and intermediality in medieval and early modern art, art at European royal courts and in royal cities, history of courtly portraits, political iconography.

Zdzisław Noga (born 1961) studied History at the Pedagogical Academy of Cracow (1980–1985), where he has worked since 1985. Doctoral thesis defended in 1993; habilitation in 2003; professor (head of the Chair of Archival Science and Auxiliary Sciences of History), dean of the Faculty of Humanities (2012–2016), member of the International Commission for the History of Towns (since 2007), chairman of the Commission for the History of Towns within the Committee of Historical Sciences of the Polish Academy of Sciences. Research interests: history of Polish towns in the Middle Ages and Early Modern Period, history of historical settlements and urban space, genealogy, history of cartography. Editor of the ›Historic Towns Atlas of Lesser Poland (Małopolska)‹ and the so-called Josephine topographic map of Galicia.

Ferdinand Opll (born 1950) studied History, German Literature and Art History at the University of Vienna. From 1975 to 1977 manager of a project on medieval history (Regesta Imperii for the reign of Frederick Barbarossa). From 1977 to 2010 at the Municipal and Provincial Archives of Vienna (Wiener Stadt- und Landesarchiv), since 1989 as its director. In 1985 he received the Venia legendi (Medieval History and Historical Auxiliary Sciences) at the University of Vienna, in 1996 he was granted with the title ›associate professor‹ (ao. Univ.-Prof.). From 2002 to 2009 head of the Ludwig-Boltzmann-Institute for Urban Historical Research (Ludwig-Boltzmann-Institut für Stadtgeschichtsforschung). Since 1992 member of the board of the International Commission for the History of Towns.

Andrea Pühringer (born 1962) studied History, German Philology and Literature, and Political Economics at the University of Vienna (Austria, 1981–1988). 1998 thesis on urban financial systems in Austrian towns of the Early Modern Period. 1993–1998 assistant

at the Institute of Economic and Social History at the University of Vienna. Since 1999 freelance historian in Germany, studies mainly on town, financial, and economic history, including atlases of Austrian and Hessian towns. Since 1995 lecturer at the University of Vienna, the Vienna University of Economics and Business, the Philipps-University in Marburg (Germany), the University of Kassel (Germany), and the University Ca' Foscari Venezia (Italy). Since 2012 member of the Historical Commission for Hesse. Publications on themes in the fields of town, cultural, financial, military, and economic history with regional emphasis on the Habsburg Monarchy and Hesse in early modern times.

Sven Rabeler (born 1971) studied Medieval and Modern History, Eastern European History and Art History in Kiel (Germany). Ph.D. 2005. Research associate at the Historical Seminar, University of Kiel, project ›Residenzstädte im Alten Reich/Residential Cities in the Holy Roman Empire (1300–1800)‹ of the Göttingen Academy of Sciences and Humanities. Research areas: medieval history, especially from social, economic and cultural perspectives – towns, urbanity and urbanisation, nobility, courts and residences, poverty, charity and hospitals. Currently, he is preparing a habilitation thesis dealing with poor relief and charitable foundations in medieval towns of the southern Baltic Sea area.

Harriet Rudolph studied History and Art History at the Eberhard Karls University of Tübingen (Germany) and Queen Mary College, University of London (UK); Ph. D. in Early Modern History, University of Trier (Germany), 1999; scientific assistant in Early Modern History at the University of Trier 2000–2008; acting professor for Early Modern History at the Johann Wolfgang Goethe University of Frankfurt (Germany) 2008–2009; professor of Modern History, University of Innsbruck (Austria) 2011; since 2012 Chair for Modern History (Early Modern Times) at the University of Regensburg (Germany). Recent publications focus, for example, on the cultural and constitutional history of the Holy Roman Empire, on the European Wars of Religion, on the material culture of early modern diplomacy.

Martin Scheutz (born 1967) studied History and German Literature at the University of Vienna (Austria); from 1996 to present teaching at the University of Vienna. Member of the Institute of Austrian Historical Research. In 2001 he received the *Venia legendi* (Modern History) at the University of Vienna. Since 2010 general secretary of the Commission for the History of Towns.

Robert Šimůnek (born 1971), Ph. D., DSc., Institute of History of the Czech Academy of Sciences, Prague. Specialist on the history and historical geography of the Late Middle Ages and Early Modern Era; main research fields: history of nobility, urban history, church history, social history (topics, for example, representation of the nobility, social networks of church institutions, relations between nobility and towns/burghers, medieval testaments); historical landscapes, cartography and iconography (symbolic testimony and documentary value of old maps and illustrations of the townscape and landscape). Co-editor of ›Historical Towns Atlas of the Czech Republic‹, editor-in-chief of the journal ›Historická geografie/Historical Geography‹.
